EVENT TOPIC: AMPLIFYING GENDER SENSITIVE APPROACHES: MALE ENGAGEMENT AND INCLUSION IN PREVENTING VIOLENCE AGAINST WOMEN AND GIRLS

1. Introduction

Engagement and inclusion of men and boys can have far reaching benefits to the gender agenda. Men and boys play a key role in the realization of gender equality and empowerment of women; however their contributions to gender equality agenda have not been fully recognized. The focus on women and girls' perspectives, has denied men the opportunity to effectively participate in the gender agenda space. Consequently, as the gender equality narrative progressed, men and boys who play a pivotal role in shaping culture have been on the periphery. To redress this anomaly, it is critical to integrate men and boys not just as allies and champions, but also as central in the promotion of the realization of gender equality, while respecting their human rights.

Globally, evidence shows that while men and boys are predominantly perpetrators of gender-based violence (GBV), they are also the custodians of cultures in patriarchal social constructs. They are therefore pivotal in addressing the challenges of violations of human rights and the resultant public health problems as recognized by the African Union Declaration 2021 on Male Engagement in Ending Violence Against Women and Girls (VAWG) and further espoused in the Kenya National Policy on Gender and Development (2019).

Inclusion of men in the gender agenda is critical to safeguarding and protecting the human rights of women and girls from violence. It is imperative that the approaches towards gender equality focus on prevention in order to eliminate all forms of GBV as alluded in the 25th anniversary of the International Conference on Population and Development (ICPD@25) Plan of Action. This therefore calls for enhanced efforts towards engagement of men and boys to realize the elimination of GBV in society.

Objectives of the Side Event

- i. To showcase the success of male engagement and inclusion in preventing violence against women and girls; and,
- ii. To learn lessons in unlocking bottlenecks in promoting positive masculinity towards accelerated GBV prevention and ending FGM/Harmful practices.

3.0 Programme Methodology

The session will be modelled around discussion plenums coordinated through a multi-sectoral approach. Discussion materials will be drawn from sector experiences but directly targeted to achieve the identified specific objectives. The panelists will showcase progress made so far on the achievements on addressing gender-based violence. Guest speakers from other regions will also be invited to share in their specific relevant experiences. The side event will be undertaken as follows:

i. **Panel Discussions:** The moderator will guide the panelists in discussions on the approaches that have employed to reduce, eliminate and address GBV.

4.0 Guiding Questions

- Which strategies have countries used to increase positive masculinity?
- Are there innovative models that can be used to increase financing for male engagement and ending GBV?
- What is the role of male engagement as a gender sensitive approach?
- What are the opportunities and challenges of male engagement to attain gender equality?
- How can this be implemented without posing a challenge on women & girls' development?
- What gains have been achieved thus far? How can we ensure that campaigns on ending GBV are truly gender transformative and that male champions have the capacities to challenge patriarchal structures that uphold gender-based violence and male domination over women?
- How can governments accelerate implementation of positive masculinity?
- What areas of synergy have been identified in policy, financing, and strategic implementation?
